Notice is hereby given that an annual and special meeting (the "**Meeting**") of the holders of common shares ("**Common Shares**") of Gear Energy Ltd. ("**Gear**" or the "**Corporation**") will be held in the Altius Centre, Conference Room +15 located at 500 – 4th Avenue S.W., Calgary, Alberta on May 11, 2016, at 3:00 p.m. (Calgary time) for the following purposes:

1. to receive the financial statements of the Corporation for the year ended December 31, 2015 and the auditors' report thereon;
2. to fix the number of directors to be elected at the Meeting at six (6) members;
3. to consider and, if thought appropriate, to elect directors of the Corporation;
4. to consider and, if thought appropriate, to appoint the auditors of the Corporation and authorizing the directors to fix their remuneration as such;
5. to consider, and, if thought appropriate, to pass with or without variation, an ordinary resolution, the full text of which is set forth in the accompanying management information circular of the Corporation dated April 11, 2016 (the "**Information Circular**"), to approve the amendment to the amending provision of the Corporation's share option plan and all unallocated options issuable under the Corporation's share option plan for a three-year period, all as more particularly described in the Information Circular;
6. to consider, and, if thought appropriate, to pass with or without variation, an ordinary resolution, the full text of which is set forth in the accompanying Information Circular, to permit the issuance of Common Shares to holders of 4.00% Series 1 convertible unsecured subordinated debentures ("**Series 1 Debentures**") on the conversion, redemption or maturity of the Series 1 Debentures pursuant to the terms and conditions of the convertible debenture indenture dated November 30, 2015 (the "**Indenture**") between the Corporation and Computershare Trust Company of Canada, all as more particularly described in the Information Circular;
7. to consider, and, if thought appropriate, to pass with or without variation, an ordinary resolution, the full text of which is set forth in the accompanying Information Circular, to permit the issuance of Common Shares to holders of 4.00% Series 2 convertible unsecured subordinated debentures ("**Series 2 Debentures**") on the conversion, redemption or maturity of the Series 2 Debentures pursuant to the terms and conditions of the Indenture, all as more particularly described in the Information Circular; and
8. to transact such further and other business as may properly come before the Meeting or any adjournment or adjournments thereof.

The nature of the business to be transacted at the Meeting and the specific details of the matters proposed to be put to the Meeting are described in further detail in the accompanying Information Circular.

The record date for the determination of shareholders entitled to receive notice of and to vote at the Meeting is April 1, 2016 (the "**Record Date**"). Shareholders of Gear whose names have been entered in the register of shareholders at the close of business on that date will be entitled to receive notice of and vote at the Meeting, provided that, to the extent a shareholder transfers the ownership of any of his or her Common Shares after such date and the transferee of those shares establishes that he or she owns the Common Shares and requests, not later than

10 days before the Meeting, to be included in the list of shareholders eligible to vote at the Meeting, such transferee will be entitled to vote those Common Shares at the Meeting.

A shareholder may attend the Meeting in person or may be represented by proxy. Shareholders who are unable to attend the Meeting or any adjournment thereof in person are requested to date, sign and return the accompanying form of proxy for use at the Meeting or any adjournment thereof. To be effective, the enclosed proxy must be mailed so as to reach or be deposited with Computershare Trust Company of Canada, Proxy Dept., 100 University Avenue, 8th Floor, Toronto, Ontario M5J 2Y1, or by facsimile at 1-866-249-7775, not later than forty-eight (48) hours (excluding Saturdays, Sundays and statutory holidays in the Province of Alberta) prior to the time set for the Meeting or any adjournment thereof. Registered shareholders may also use the internet site at www.investorvote.com to transmit their voting instructions or vote by phone at 1-866-732-VOTE (8683) (toll free within North America) or 1-312-588-4290 (outside North America).

The instrument appointing a proxy shall be in writing and shall be executed by the shareholder or his attorney authorized in writing or, if the shareholder is a corporation, under its corporate seal by an officer or attorney thereof duly authorized.

The persons named in the enclosed form of proxy are directors and/or officers of the Corporation. Each shareholder has the right to appoint a proxyholder other than such persons, who need not be a shareholder, to attend and to act for such shareholder and on such shareholder's behalf at the Meeting. To exercise such right, the names of the nominees of management should be crossed out and the name of the shareholder's appointee should be legibly printed in the blank space provided.

Solicitation of Proxies

This management information circular (this "**Information Circular**") is furnished in connection with the solicitation of proxies by the management of Gear Energy Ltd. ("**Gear**" or the "**Corporation**") for use at the annual and special meeting (the "**Meeting**") of the holders ("**Shareholders**") of common shares ("**Common Shares**") of the Corporation to be held on Wednesday, May 11, 2016 at 3:00 p.m. (Calgary time) in the Altius Centre, Conference Room +15 located at 500 – 4th Avenue S.W., Calgary, Alberta and at any adjournment thereof, for the purposes set forth in the Notice of Meeting.

Forms of proxy must be addressed to and reach Computershare Trust Company of Canada, Proxy Dept., 100 University Avenue, 8th Floor, Toronto, Ontario M5J 2Y1, or by facsimile at 1-866-249-7775, not less than 48 hours (excluding Saturdays, Sundays and holidays) before the time for the holding of the Meeting or any adjournment thereof.

The board of directors of the Corporation (the "**Board**") has fixed the record date for the Meeting at the close of business on April 1, 2016 (the "**Record Date**").

Registered shareholders may also use the internet site at www.investorvote.com to transmit their voting instructions or vote by phone at 1-866-732-VOTE (8683) (toll free within North America) or 1-312-588-4290 (outside North America). Shareholders should have the form of proxy in hand when they access the website and will be prompted to enter their control number, which is located on the form of proxy. If Shareholders vote by internet, their vote must be received not less than 48 hours (excluding Saturdays, Sundays and holidays) before the time for the holding of the Meeting. The website may be used to appoint a proxy holder to attend and vote on a Shareholder's behalf at the Meeting and to convey a Shareholder's voting instructions.

Shareholders of record as at the Record Date are entitled to receive notice of the Meeting and to vote their Common Shares, included in the list of Shareholders entitled to vote at the Meeting prepared as at the Record Date, except to the extent that any such Shareholder transfers their Common Shares after the Record Date and the transferee of such Common Shares, having produced properly endorsed certificates evidencing such Common Shares or having otherwise established that he or she owns such Common Shares, demands, not later than ten (10) days before the Meeting, that the transferee's name be included in the list of Shareholders entitled to vote at the Meeting, in which case such transferee shall be entitled to vote such Common Shares at the Meeting.

Unless otherwise stated, information provided in this Information Circular is given as at April 1, 2016.

The instrument appointing a proxy shall be in writing and shall be executed by the Shareholder or the Shareholder's attorney authorized in writing or, if the Shareholder is a corporation, under its corporate seal or by an officer or attorney thereof duly authorized.

The persons named in the enclosed form of proxy are directors and officers of the Corporation. Each Shareholder has the right to appoint a proxyholder other than the persons designated above, who need not be a Shareholder, to attend and to act for the Shareholder at the Meeting. To exercise such right, the names of the nominees of management should be crossed out and the name of the Shareholder's appointee should be legibly printed in the blank space provided.

Beneficial Holders of Common Shares

The information set forth in this section is provided to beneficial holders of Common Shares of the Corporation who do not hold their Common Shares in their own name ("**Beneficial Shareholders**"). Beneficial Shareholders should note that only proxies deposited by Shareholders whose names appear on the records of the Corporation as the registered holders of Common Shares can be recognized and acted upon at the Meeting. If Common Shares are listed in an account statement provided to a Beneficial Shareholder by a broker, then in almost all cases those Common Shares will not be registered in the Beneficial Shareholder's name on the records of the Corporation. Such Common Shares will more likely be registered under the name of the Beneficial Shareholder's broker or an agent of that broker. In Canada, the vast majority of such shares are registered under the name of CDS & Co. (the registration name for CDS Clearing and Depository Services Inc., which acts as nominees for many Canadian brokerage firms). Common Shares held by brokers or their nominees can only be voted (for or against resolutions) upon the instructions of the Beneficial Shareholder. Without specific instructions, the broker/nominees are prohibited from voting Common Shares for their clients. The Corporation does not know for whose benefit the shares registered in the name of CDS & Co. are held.

Applicable regulatory policy requires intermediaries/brokers to seek voting instructions from Beneficial Shareholders in advance of Shareholders' meetings. Every intermediary/broker has its own mailing procedures and provides its own return instructions, which should be carefully followed by Beneficial Shareholders in order to ensure that their Common Shares are voted at the Meeting. The majority of brokers now delegate responsibility for obtaining instructions from clients to Broadridge Financial Solutions, Inc. ("**Broadridge**"). Broadridge typically provides a scannable voting request form or applies a special sticker to the proxy forms, mails those forms to the Beneficial Shareholders and asks Beneficial Shareholders to return the voting request forms or proxy forms to Broadridge. Often Beneficial Shareholders are alternatively provided with a toll-free telephone number to vote their shares or website address where shares can be voted. Broadridge then tabulates the results of all instructions received and provides appropriate instructions respecting the voting of shares to be represented at the Meeting. **A Beneficial Shareholder receiving a voting instruction request or a proxy with a Broadridge sticker on it cannot use that instruction request or proxy to vote Common Shares directly at the Meeting as the proxy must be returned as directed by Broadridge well in advance of the Meeting in order to have the Common Shares voted. Accordingly, it is strongly suggested that Beneficial Shareholders return their completed instructions or proxies as directed by Broadridge well in advance of the Meeting.**

Although a Beneficial Shareholder may not be recognized directly at the Meeting for the purposes of voting Common Shares registered in the name of his or her broker (or agent of the broker), a Beneficial Shareholder may attend the Meeting as proxyholder for the registered Shareholder and vote their Common Shares in that capacity. Beneficial Shareholders who wish to attend the Meeting and indirectly vote their Common Shares as proxyholder for the registered Shareholder should enter their own names in the blank space on the form of proxy provided to them and return the same to their broker (or the broker's agent) in accordance with the instructions provided by such broker (or agent), well in advance of the Meeting.

The Corporation is not using "notice-and-access" to send its proxy-related materials to its Shareholders, and paper copies of such materials will be sent to all Shareholders. The Corporation will not send proxy-related materials directly to non-objecting Beneficial Shareholders and such materials will be delivered to non-objecting Beneficial Shareholders through their intermediary. The Corporation intends to pay for an intermediary to deliver to objecting Beneficial Shareholders the proxy-related materials and Form 54-101F7 – *Request for Voting Instructions Made by Intermediary* of National Instrument 54-101.

Revocability of Proxy

A Shareholder who has submitted a proxy may revoke it at any time prior to the exercise thereof. If a person who has given a proxy attends personally at the Meeting at which such proxy is to be voted, such person may revoke the proxy and vote in person. In addition to revocation in any other manner permitted by law, a proxy may be revoked by instrument in writing executed by the Shareholder or the Shareholder's attorney authorized in writing deposited either at the registered office of the Corporation at any time up to and including the last business day preceding the day of the Meeting or any adjournment thereof or with the Chairman of the Meeting on the day of the Meeting or any adjournment thereof prior to the commencement of the Meeting.

Persons Making the Solicitation

The solicitation is made on behalf of the management of the Corporation. The costs incurred in the preparation and mailing of the enclosed form of proxy, Notice of Meeting and this Information Circular will be borne by the Corporation. In addition to solicitation by mail, proxies may be solicited by personal interviews, telephone or other means of communication and by directors, officers and employees of the Corporation, who will not be specifically remunerated therefore.

Exercise of Discretion by Proxy

The Common Shares represented by proxy in favour of management nominees shall be voted on any ballot at the Meeting and, where the Shareholder specifies a choice with respect to any matter to be acted upon, the Common Shares shall be voted or withheld from voting on any ballot in accordance with the specification so made.

In the absence of such specification, the Common Shares will be voted in favour of the matters to be acted upon. The persons appointed under the form of proxy furnished by the Corporation are conferred with discretionary authority with respect to amendments or variations of those matters specified in the enclosed form of proxy, the Notice of Meeting and this Information Circular. At the time of printing this Information Circular, management of the Corporation knows of no such amendment, variation or other matter.

MATTERS TO BE ACTED UPON AT THE MEETING

1. Financial Statements and Auditors' Report

Pursuant to the *Business Corporations Act* (Alberta) (the "ABCA"), the Board will place before the Shareholders at the Meeting the audited financial statements of the Corporation for the year ended December 31, 2015 and the auditors' report thereon, accompanying this Information Circular. Shareholder approval is not required in relation to the audited financial statements.

2. Fixing Number of Directors

At the Meeting, Shareholders will be asked to fix the number of directors to be elected at the Meeting at six (6) members. There are currently six (6) directors of the Corporation, being Greg Bay, Raymond Cej, Harry English, Don T. Gray, Ingram Gillmore and Peter Verburg, each of whom is nominated for election at the Meeting, as stated below.

Unless otherwise directed, it is the intention of management to vote proxies in the accompanying form in favour of fixing the number of directors to be elected at the Meeting at six (6) members.

3. Election of Directors

At the Meeting, Shareholders will be asked to elect six (6) directors to hold office until the next annual general meeting or until their successors are elected or appointed.

Unless otherwise directed, it is the intention of management to vote proxies in the accompanying form in favour of the election as directors of the six (6) nominees hereinafter set forth:

The directors will be elected on an individual basis. The voting for or against and approval of one director will be mutually exclusive to the voting for or against and approval of any other director.

The names, provinces and countries of residence of the persons nominated for election as directors, the number of voting securities of the Corporation beneficially owned or directed or controlled, directly or indirectly, the offices held by each in the Corporation, the period served as director and the principal occupation and background of each are set forth below. Majority Voting for Directors

The Board has adopted a policy stipulating that if the number of Common Shares voted in favour of the election of a particular director nominee at a Shareholders' meeting is less than the number of Common Shares voted and withheld from voting for that nominee, the nominee will submit his resignation to the Board, with the resignation to take effect when and if such resignation is accepted by the Board. The Compensation and Governance Committee will consider the director nominee's offer to resign and will make a recommendation to the Board as to whether or not to accept the resignation. The Compensation and Governance Committee will be expected to recommend acceptance of the resignation except in exceptional circumstances.

The Board will consider the Compensation and Governance Committee's recommendation and make a decision as to whether to accept the director's offer to resign within 90 days of the date of the meeting. The decision of the Board will be announced by way of a press release, which, if the Board has decided to reject such resignation, the reasons for rejecting the resignation. No director who is required to tender his resignation shall participate in the deliberations or recommendations of the Compensation and Governance Committee or the Board. The Board shall accept the resignation absent any exceptional circumstances.

If a director's offer of resignation is accepted, at the Board's discretion, it may fill the vacancy through the appointment of a new director whom the Board considers appropriate in accordance with the Corporation's by-laws and articles and applicable laws. The foregoing policy does not apply in circumstances involving contested director elections.

Advance Notice By-law

The Corporation has adopted an advance notice by-law regarding advance notice of nominations of directors of the Corporation (the "**Advance Notice By-law**"). The Advance Notice By-law provides that advance notice to the Corporation must be made in circumstances where nominations of persons for election to the Board are made by Shareholders other than pursuant to: (a) a "proposal" made in accordance with the ABCA; or (b) a requisition of a meeting made pursuant to the ABCA.

The Advance Notice By-law fixes a deadline by which Shareholders must submit director nominations to the Chief Financial Officer of the Corporation prior to any annual or special meeting of Shareholders and outlines the specific

information that a nominating Shareholder must include in the written notice to the Chief Financial Officer of the Corporation for an effective nomination to occur. No person nominated by a Shareholder will be eligible for election as a director of the Corporation unless nominated in accordance with the provisions of the Advance Notice By-law.

In the case of an annual meeting of Shareholders, notice to the Chief Financial Officer of the Corporation must be made not less than 30 days and not more than 65 days prior to the date of the annual meeting; provided, however, that in the event that the annual meeting is to be held on a date that is less than 50 days after the date on which the first public announcement of the date of the annual meeting was made, notice may be made not later than the close of business on the 10th day following such public announcement. In the case of a special meeting of Shareholders (which is not also an annual meeting), notice to the Corporation must be made not later than the close of business on the 15th day following the day on which the first public announcement of the date of the special meeting was made.

The Board may, in its sole discretion, waive any requirement of the Advance Notice By-law.

Corporate Cease Trade Orders or Bankruptcies

Other than as disclosed below, no proposed director is as at the date hereof, or has been, within 10 years of the date hereof, a director or chief executive officer or chief financial officer (or any executive officer, for the purpose of subsection (iii)) of any company, including the Corporation, that: (i) while that person was acting in that capacity, was the subject of a cease trade or similar order or an order that denied the relevant company access to any exemption under securities legislation, for a period of more than 30 consecutive days (an "**order**"); (ii) after that person ceased to act in that capacity, was the subject of an order that resulted from an event that occurred while that person was acting in the capacity as a director, chief executive officer or chief financial officer, or (iii) is or has, within 10 years before the date of this Information Circular become bankrupt, made a proposal under any legislation relating to bankruptcy or insolvency or became subject to or instituted any proceedings, arrangement or compromise with creditors, or had a receiver, receiver manager or trustee appointed to hold its assets, while that person was acting in that capacity.

Mr. Cej was, prior to January 26, 2010, a trustee of Impax Energy Services Income Trust (the "**Trust**"). On December 14, 2009, the Trust filed for creditor protection in order to facilitate an orderly sale and wind-up of operations. On January 26, 2010, all of the trustees and directors of the Trust resigned following the sale of substantially all of the assets of the Trust. Upon the resignations of the trustees and directors, trading in the units of the Trust was suspended for failure to maintain a minimum number of directors as required under the rules of the TSX Venture Exchange.

No proposed director has, within the 10 years before the date of this Information Circular, become bankrupt, made a proposal under any legislation relating to bankruptcy or insolvency, or become subject to or instituted any proceeding, arrangement or compromise with creditors or had a receiver, receiver manager or trustee appointed to hold the assets of the proposed director.

Penalties or Sanctions

No proposed director has been subject to: (i) any penalties or sanctions imposed by a court relating to securities legislation or by a securities regulatory authority or has entered into a settlement agreement with a securities regulatory authority, or (ii) any other penalties or sanctions imposed by a court or regulatory body that would likely be considered important to a reasonable security holder in deciding whether to vote for a proposed director.

4. Appointment of Auditors

Unless otherwise directed, it is management's intention to vote the proxies in favour of appointing the firm of Deloitte LLP, Chartered Accountants, of Calgary, Alberta to serve as auditors of the Corporation until the next annual general meeting of the Shareholders and to authorize the directors to fix their remuneration as such. The appointment of the auditors must be approved by a majority of votes cast by the Shareholders. Deloitte LLP have been the Corporation's auditors since March 2, 2010.

5. Approval of Option Plan Amendments and Unallocated Options

On April 11, 2016, certain amendments (the "**Option Plan Amendments**") to the Corporation's share option plan (the "**Option Plan**") were approved by the Board to (i) restrict the aggregate number of Common Shares that may be issued to non-management directors pursuant to the exercise of options to purchase Common Shares ("**Options**") awarded under the Option Plan to a maximum of 1% of the Common Shares outstanding from time to time and to restrict the aggregate value of Options that may be granted to any one non-management director in any one year period to a maximum of \$100,000; (ii) amend the amending provision of the Option Plan to restrict the Board's ability to increase the maximum number of Options that may be granted to non-management directors without Shareholder approval; (iii) amend the change of control provision of the Option Plan to provide that the vesting of Options upon a change of control would only occur if the grantee is terminated in connection with such change of control or voluntarily resigns within 6 months of such change of control for "Good Reason" (as such term is defined in the Option Plan); and (iv) to make certain other minor housekeeping amendments; however, as indicated in the below resolution, the amendment to the amending provision of the Option Plan requires the approval of Shareholders pursuant to the terms of the Option Plan. The Option Plan Amendments noted at (i), (iii) and (iv) above do not require the approval of Shareholders at the Meeting.

Additionally, the policies of the Toronto Stock Exchange (the "**TSX**") require that shareholders must approve all unallocated options under the Option Plan every three years. The Corporation's current unallocated Options expire on November 18, 2016, being the three year anniversary from the date of listing of the Common Shares on the TSX.

Therefore, at the Meeting, Shareholders will be asked to approve an ordinary resolution approving the amendment to the amending provision of the Option Plan and the unallocated Options under the Option Plan.

When Options have been granted pursuant to the Option Plan, Common Shares that are reserved for issuance under an outstanding Option are referred to as "allocated options". The Corporation has additional Common Shares that may be issued under the Option Plan, but as they are not subject to current Option grants, they are referred to as "unallocated options". As of the date hereof, the Corporation has Options to purchase 6,458,573 Common Shares (equal to approximately 7.6% of the Corporation's issued and outstanding Common Shares as of the date hereof) outstanding under the Option Plan, leaving unallocated Options to purchase an aggregate of 2,089,800 Common Shares (equal to approximately 2.4% of the Corporation's issued and outstanding Common Shares as of the date hereof) available for future grants based on the number of outstanding Common Shares.

As discussed under "*Statement of Executive Compensation – Compensation Discussion and Analysis – Elements of the Corporation's Executive Compensation Program – Long-Term Incentive Compensation*", as with most companies in the Corporation's peer group, Options form an important part of the total compensation provided to the Corporation's officers and employees. Options are provided to align employee and Shareholder interests by attempting to create a direct link between compensation and Shareholder return. In addition, as Options do not require any payment of cash by the Corporation, Options help the Corporation preserve cash which can then be used for capital expenditures relating to exploration and development plans for the continued growth of the Corporation. If unallocated Options are not approved by the Shareholders at the Meeting, the Board will have to consider alternative forms of compensation to replace the grant of Options to attract, compensate and incentivize officers and employees.

Additional details of the Option Plan are provided under "*Statement of Executive Compensation – Incentive Plan Awards – Option Plan*". A copy of the Option Plan, as amended, is set forth in Schedule "B" attached hereto and forming part of this Information Circular. The Board approval of the amendments to the Option Plan will only become effective if the resolution approving the unallocated Options is passed by the Shareholders at the Meeting.

At the Meeting, Shareholders will be asked to approve an ordinary resolution in the following form approving the amendment to the amending provision of the Option Plan and all unallocated Options issuable under the Option Plan:

"BE IT RESOLVED, AS AN ORDINARY RESOLUTION OF THE SHAREHOLDERS OF GEAR ENERGY LTD. (THE "**CORPORATION**"):

1. the amendment to Section 18 of the share option plan of the Corporation described in the management information circular of the Corporation dated April 11, 2016 be and the same are hereby approved;
2. any director or officer of the Corporation be and is hereby authorized and directed to do such things and to execute and deliver all such instruments, deeds and documents, and any amendments thereto, as may be necessary or advisable in order to give effect to the foregoing resolutions, and to complete all transactions in connection therewith; and
3. that all unallocated options issuable under the Corporation's share option plan be approved until the third anniversary of the date that this resolution is passed, being May 11, 2019."

Pursuant to the requirements of the TSX, the foregoing resolution must be approved by a simple majority of the votes cast at the meeting by the Shareholders voting in person or by proxy at the Meeting.

Currently outstanding Options will be unaffected if this resolution is not approved, but currently outstanding Options which have been exercised or that have expired or been cancelled will not be available for re-grant and the Board will not be able to grant new Options if the unallocated Options are not approved.

Unless otherwise directed, it is the intention of the persons named in the enclosed form of proxy, if named as proxy, to vote for approval of the foregoing resolution approving all unallocated Options under the Option Plan.

6. **Approval of Conversion Right of Series 1 Debentures**

On November 30, 2015, the Corporation completed: (i) a public offering of 12,000,000 Common Shares at a price of \$0.75 per Common Share (the "**Prospectus Offering**"); (ii) a private placement of 2,666,700 Common Shares at a price of \$0.75 per Common Share (the "**2015 Share Private Placement**"); and (iii) a private placement of \$14,800,000 aggregate principal amount of 4.00% convertible unsecured subordinated debentures (the "**Convertible Debentures**") of the Corporation, which were issued in two series, at a price of \$1,000 per Convertible Debenture (the "**2015 Debenture Private Placement**" and, collectively, with the Prospectus Offering and the 2015 Share Private Placement, the "**Financing**"), for aggregate gross proceeds from the Prospectus Offering, 2015 Share Private Placement and 2015 Debenture Private Placement of approximately \$25.8 million. Burgundy Asset Management Ltd. (the "**Significant Shareholder**"), a significant shareholder of the Corporation, purchased all of the Common Shares pursuant to the 2015 Share Private Placement and \$11.593 million aggregate principal amount of 4.00% Series 2 Convertible Debentures (the "**Series 2 Debentures**") pursuant to the 2015 Debenture Private Placement, representing 78.3% of the 2015 Debenture Private Placement.

Concurrently, with announcing the Financing, the Corporation announced that the borrowing base of its syndicated bank credit facilities (the "**Credit Facilities**") were been reduced from \$90,000,000 to \$60,000,000. As prior to completion of the Financing, the Corporation's indebtedness under the Credit Facilities were higher than the new borrowing base the Financing was critical to the continuing business and operations of the Corporation.

Pursuant to the terms of the Corporation's outstanding 4.00% Series 1 Convertible Debentures (the "**Series 1 Debentures**"), which were issued pursuant to a convertible debenture indenture dated November 30, 2015 (the "**Indenture**") between the Corporation and Computershare Trust Company of Canada, the issuance of Common Shares on conversion, redemption or maturity of the Series 1 Debentures, together with the Series 2 Debentures, may result in dilution of greater than 25% of the number of Common Shares outstanding, on a non-diluted basis, immediately prior to the date of the issuance of the Series 1 Debentures. As a result, the issuance of Common Shares on conversion, redemption or maturity of the Series 1 Debentures requires approval of the Shareholders (the "**Series 1 Shareholder Resolution**") in accordance with the rules of the TSX and the Indenture to permit the

issuance of Common Shares to the holders of the Series 1 Debentures on the conversion, redemption or maturity of the Series 1 Debentures.

If the Series 1 Shareholder Resolution and Series 2 Shareholder Resolution (as defined below) are approved, the Series 1 Debenture and Series 2 Debentures will be convertible into Common Shares at the election of the holder of such Convertible Debentures based on a conversion price of \$0.87 per Common Share. As a result, an aggregate of up to 3,686,207 Common Shares may be issued on conversion of the Series 1 Debentures and up to 13,325,287 Common Shares may be issued on conversion of the Series 2 Debentures for an aggregate of up to 17,011,494 Common Shares.

Subject to receiving the Series 1 Shareholder Resolution and Series 2 Shareholder Resolution, the Corporation will also have the option to satisfy its obligation to repay the principal amount of the Convertible Debentures due at maturity or redemption of the Convertible Debentures by the issuance of Common Shares and the number of such Common Shares will be based on 95% of the weighted average trading price of the Common Shares prior to the date fixed for maturity or redemption. As the number of Common Shares to be issued on redemption or maturity is based on a price to be determined at a later date, the maximum number of Common Shares that may be issued upon such redemption or maturity is not determinable at the present time.

If the Series 1 Shareholder Resolution is not approved, the interest rate payable on the Series 1 Debentures will increase to 6.00% per annum payable on the interest payment dates set forth in the Indenture commencing with the interest payment date on May 31, 2016.

Pursuant to the rules of the TSX and the Indenture, the Corporation is required to obtain Shareholder approval of the Series 1 Shareholder Resolution. As such, at the Meeting, Shareholders will be asked to approve the following resolution:

"BE IT RESOLVED, AS AN ORDINARY RESOLUTION OF THE SHAREHOLDERS OF GEAR ENERGY LTD. (THE "**CORPORATION**"):

1. the issuance of common shares of the Corporation upon the conversion, redemption or maturity of the 4.00% Series 1 convertible unsecured subordinated debentures (the "**Series 1 Debentures**") of the Corporation in accordance with the convertible debenture indenture dated November 30, 2015 between the Corporation and Computershare Trust Company of Canada, which may be greater than 25% of the number of common shares of the Corporation outstanding, on a non-diluted basis, immediately prior to the date of issuance of the Series 1 Debentures, as more particularly described in the management information circular statement of the Corporation dated April 11, 2016, be and the same are hereby approved; and
2. any director or officer of the Corporation be and is hereby authorized and directed to do such things and to execute and deliver all such instruments, deeds and documents, and any amendments thereto, as may be necessary or advisable in order to give effect to the foregoing resolutions, and to complete all transactions in connection therewith."

In accordance with the rules of the TSX, the Series 1 Shareholder Resolution requires approval of the majority of the votes cast at the meeting, in person or by proxy.

The Board recommends that Shareholders vote in favour of the Series 1 Shareholder Resolution. **Unless otherwise directed, it is the intention of the persons named in the enclosed form of proxy, if named as proxy, to vote for approval of the Series 1 Shareholder Resolution.**

7. **Approval of Conversion Right of Series 2 Debentures**

Pursuant to the terms of the Corporation's outstanding Series 2 Debentures, which were issued pursuant to the Indenture, the issuance of Common Shares on conversion, redemption or maturity of the Series 2 Debentures, together with the Series 1 Debentures, may result in: (i) dilution of greater than 25% of the number of Common Shares outstanding, on a non-diluted basis, immediately prior to the date of the issuance of the Series 2 Debentures; (ii) the creation of a new control person, the Significant Shareholder (control person includes any person or entity that holds, or is one of a combination of persons or entities that holds, a sufficient number of any of the securities of an issuer so as to affect materially the control of that issuer, or that holds more than 20% of the outstanding voting shares of an issuer subject to certain exceptions (a "**Control Person**")); and (iii) the issuance of Common Shares in excess of 10% of the issued and outstanding Common Shares immediately prior to the date of the issuance of the Series 2 Debentures to insiders (as defined in the rules of the TSX) of the Corporation.

As a result, the issuance of Common Shares on conversion, redemption or maturity of the Series 2 Debentures requires approval of the Shareholders (the "**Series 2 Shareholder Resolution**") in accordance with the rules of the TSX and the Indenture to permit: (i) the issuance of Common Shares to the holders of the Series 2 Debentures on the conversion, redemption or maturity of the Series 2 Debentures; (ii) the resulting material effect on control of the Corporation (i.e. the potential creation of a new Control Person, the Significant Shareholder, that may own more than 20% of the issued and outstanding Common Shares) resulting from the issuance of Common Shares upon the conversion, redemption or maturity of the Series 2 Debentures; and (iii) the issuance of Common Shares in excess of 10% of the issued and outstanding Common Shares immediately prior to the date of the Series 2 Debentures to insiders of the Corporation.

The Significant Shareholder currently owns 16,541,041 Common Shares, representing approximately 19.3% of the issued and outstanding Common Shares. Additionally, the Significant Shareholder owns \$11.593 million aggregate principal amount of the outstanding Series 2 Debentures, representing 100% of the issued and outstanding Series 2 Debentures. Assuming that, on the date immediately following the closing of the Financing, the Significant Shareholder were to convert all of its Series 2 Debentures into Common Shares and that no Series 1 Debentures were converted, the Significant Shareholder would have held 29,866,328 Common Shares, representing approximately 30.2% of the Common Shares then outstanding. This would result in the Significant Shareholder becoming a Control Person of the Corporation.

For additional details on the rationale for the issuance of the Series 2 Debentures and the number of Common Shares that may be issued on conversion, redemption or maturity of the Series 2 Debentures, see "*Approval of Conversion Rights of Series 1 Debentures*" above.

If the Series 2 Shareholder Resolution is not approved, the interest rate payable on the Series 2 Debentures will increase to 6.00% per annum payable on the interest payment dates set forth in the Indenture commencing with the interest payment date on May 31, 2016.

Pursuant to the rules of the TSX and the Indenture, the Corporation is required to obtain Shareholder approval of the Series 2 Shareholder Resolution. As such, at the Meeting, Shareholders will be asked to approve the following resolution:

"BE IT RESOLVED, AS AN ORDINARY RESOLUTION OF THE SHAREHOLDERS OF GEAR ENERGY LTD. (THE "**CORPORATION**)":

1. the issuance of common shares ("**Common Shares**") of the Corporation upon the conversion, redemption or maturity of the 4.00% Series 2 convertible unsecured subordinated debentures (the "**Series 2 Debentures**") of the Corporation in accordance with the convertible debenture indenture dated November 30, 2015 (the "**Indenture**") between the Corporation and Computershare Trust Company of Canada, which may be greater than 25% of the number of common shares of the Corporation outstanding, on a non-diluted basis, immediately prior to the date of the issuance of the Series 2

Debentures, as more particularly described in the management information circular of the Corporation dated April 11, 2016 (the "**Information Circular**"), be and the same are hereby approved;

2. the issuance of Common Shares upon the conversion, redemption or maturity of the Series 2 Debentures in accordance with the Indenture, pursuant to which Burgundy Asset Management Ltd. may acquire greater than 20% of the number of Common Shares then outstanding, on a non-diluted basis, and accordingly materially affect control of the Corporation, as more particularly described in the Information Circular, be and the same are hereby approved; and
3. the issuance of Common Shares upon the conversion, redemption or maturity of the Series 2 Debentures in accordance with the Indenture, pursuant to which will result in excess of 10% of the issued and outstanding Common Shares immediately prior to the date of the Indenture to insiders of the Corporation, as more particularly described in the Information Circular, be and the same are hereby approved; and
4. any director or officer of the Corporation be and is hereby authorized and directed to do such things and to execute and deliver all such instruments, deeds and documents, and any amendments thereto, as may be necessary or advisable in order to give effect to the foregoing resolutions, and to complete all transactions in connection therewith."

In accordance with the rules of the TSX, the Series 2 Shareholder Resolution requires approval of the majority of the votes cast at the meeting, in person or by proxy. For the purposes of the Series 2 Shareholder Resolution, approval must be obtained on a disinterested basis such that the Common Shares held by any insider of the Corporation who has purchased Series 2 Debentures shall be excluded from the vote. As a result, the Common Shares held by the Significant Shareholder, who currently owns, controls or directs, directly or indirectly, approximately 16.2% of the issued and outstanding Common Shares shall be excluded from voting on the Series 2 Shareholder Resolution.

The Board recommends that Shareholders vote in favour of the Series 2 Shareholder Resolution. **Unless otherwise directed, it is the intention of the persons named in the enclosed form of proxy, if named as proxy, to vote for approval of the Series 2 Shareholder Approval.**

STATEMENT OF EXECUTIVE COMPENSATION

Compensation Discussion and Analysis

The Corporation's compensation program is administered by the Compensation and Governance Committee (the "**Compensation and Governance Committee**") of the Board. The Compensation and Governance Committee, amongst its other responsibilities, reviews and recommends annually to the Board the remuneration of the Corporation's executive officers, employees and directors.

The members of the Compensation and Governance Committee during the year ended December 31, 2015 were comprised of Greg Bay, Raymond Cej, Don T. Gray and Peter Verburg, all of whom are highly experienced executives, directors and/or businessmen who have dealt with compensation issues in the course of their respective leadership roles and each are independent. The skills and experience that enable the members of the Compensation and Governance Committee to make decisions on the suitability of the Corporation's compensation policies and practices is as follows:

- Mr. Bay is the founding partner, President of Cypress Capital Management (a private investment firm) from 1998 to present. In that role he has extensive experience in analyzing and understanding market views and perception of public companies. Mr. Bay also sits on the board of directors of Mullen Group Ltd. and is on compensation committee of Mullen Group Ltd. Mr. Bay has a Chartered Financial Analyst designation and holds a Bachelor of Commerce degree from Brigham Young University.
- Mr. Cej is an independent businessman and was previously the President of Teine Energy Ltd., a private oil and gas company. His primary oil and gas experience was gained through a 26-year career with Shell Canada Ltd., culminating with senior executive responsibility for all of Shell's upstream activities. Mr. Cej has also served as an independent director on several boards of directors including First Calgary Petroleum Ltd., Canada Southern Petroleum Ltd., Brooklyn Energy Corporation and Geocan Energy Inc. Mr. Cej is a registered professional engineer in Ontario and Alberta and holds a Bachelor of Engineering in Chemical Engineering (Royal Military College) and Master of Sciences, Chemical Engineering (California Institute of Technology).
- Mr. Gray holds a Bachelor of Sciences in Petroleum Engineering from Texas A&M University and has over 25 years experience in the Canadian oil and gas business in various capacities. Mr. Gray is the Chairman of Gear and is a Co-Founder and former President and Chief Executive Officer of Peyto. Mr. Gray is also Chairman and co-founder of Petrus Resources Ltd., and Chairman of EIQ Capital Corp., a private investment company.
- Mr. Verburg holds a Masters of Business Administration from the University of Calgary. He is currently the President of EIQ Capital Corp., a private investment company. He was formerly Managing Director of EIQ Capital from 2008 to 2013, and prior thereto an officer at GMP Securities L.P., working in the Corporate Finance energy group from 2005 to 2008. Prior thereto, Mr. Verburg was a member of the editorial board at a leading financial periodical, and held other senior positions in the communications industry. Mr. Verburg is also a co-founder and director of Petrus Resources Ltd.

At no time in the two most recently completed financial years, has the Corporation retained a compensation consultant or advisor to assist the Board or the Compensation and Governance Committee in determining the compensation of the directors or executive officers of the Corporation.

The Corporation's compensation philosophy includes a "pay-for-performance" element, which supports the Corporation's desire to deliver continuous, strong performance for its shareholders. In addition, the Corporation's compensation philosophy is aimed at attracting and retaining quality and experienced people, which is critical to the success of the Corporation for the benefit of its shareholders. Employee compensation, including executive officer compensation, is comprised of three elements: base salary, short-term incentive compensation (cash bonuses) and long-term incentive compensation (Options). The Compensation and Governance Committee reviews all components in assessing the compensation paid to individual executive officers and paid by the Corporation as a whole. Salaries and bonuses are intended to provide current compensation and a short-term incentive for employees to meet the Corporation's goals, as well as to remain competitive with the industry. Options are granted as a long-term incentive and to encourage commitment to the Corporation.

When determining executive compensation, the Compensation and Governance Committee gives regard to the contributions made by officers, how their compensation levels relate to compensation packages that would be achievable from other opportunities, available salary survey data and other information publically disclosed by some of the Corporation's competitors and peers. As well, the Compensation and Governance Committee considers the Corporation's and individual's performance in relation to production, reserve growth, cash flows (including, in each case, on a debt adjusted per share basis) and other strategic objectives. A total of 12 publicly traded junior energy companies were reviewed to assess the competitive nature of Corporation's compensation using data contained in various information circulars. These companies ranged from approximately \$125 million to \$425 million enterprise values for the year ended December 31, 2015. From that data, an average was calculated and considered in determining the appropriate compensation for the Corporation's officers. The following peers were considered as part of this evaluation with respect to the year ended December 31, 2015: Marquee Energy Ltd., Yangarra Resources Inc., Strategic Oil and Gas Ltd., Manitek Energy Inc., Anderson Energy Inc., Arsenal Energy Inc., Rock Energy Inc., Zargon Oil and Gas Ltd., Chinook Energy Inc., Arcan Resources Ltd., Tamarack Valley Energy Ltd., and BlackPearl Resources Ltd.

The President and Chief Executive Officer ("**CEO**" or "**Chief Executive Officer**") of the Corporation is responsible for making recommendations to the Compensation and Governance Committee with respect to compensation for the executive officers of the Corporation, including the CEO. In making such recommendations, the CEO analyzes a number of factors including compensation data compiled from the Corporation's peer groups, corporate performance and individual executive officer performance. In assessing corporate performance, the Corporation does not have any pre-determined set targets, but the following factors are considered: (a) year over year growth in reserves value; (b) the Corporation's performance relative to its industry peer group; (c) cash flow and cash flow per share amounts; (d) total operating costs and total general and administrative costs, as well as operating costs and general and administrative costs per barrel of oil equivalent; and (e) annual finding, development and acquisitions costs. In assessing the performance of individual executive officers, consideration is given to objective factors such as level of responsibility, experience and expertise, as well as subjective factors such as leadership and performance in such executive officer's specific role with the Corporation.

The CEO then makes a recommendation to the Compensation and Governance Committee with respect to the various elements of compensation to be awarded to each executive officer. The CEO also presents his analysis of corporate performance and individual executive officer performance to the Compensation and Governance Committee.

Upon the receipt of such recommendation, the Compensation and Governance Committee reviews the evaluation in addition to the compensation data compiled with respect to the Corporation's peer group and determines whether to accept the recommendation or make any changes. Recommendations for executive compensation, as well as for compensation paid by the Corporation as a whole, are then made by the Compensation and Governance Committee to the Board for approval.

At no time in Gear's previous two completed financial years has a compensation consultant or advisor been formally retained by Gear to assist the Board or the Compensation and Governance Committee to determine the compensation of the directors or executive officers of Gear.

Short Sales, Puts, Calls and Options

Pursuant to the Corporation's Disclosure, Confidentiality and Trading Policy, directors, officers and employees of the Corporation shall not knowingly sell, directly or indirectly, a security of the Corporation if such person selling such security does not own or has not fully paid for the security to be sold. Directors, officers and employees of the Corporation shall not, directly or indirectly, buy or sell a call or put in respect of a security of the Corporation. Notwithstanding these prohibitions, directors, officers and employees of the Corporation may sell a Common Share which such person does not own if such person owns another security convertible into Common Shares or an option or right to acquire Common Shares sold and, within 10 days after the sale, such person: (i) exercises the conversion privilege, option or right and delivers the Common Shares so associated to the purchaser; or (ii) transfers the convertible security, option or right, if transferable to the purchaser.

Elements of the Corporation's Executive Compensation Program

Each element of the Corporation's executive compensation program is described in more detail below.

Base Salaries

The Compensation and Governance Committee recognizes that the size of the Corporation prohibits base salary compensation for executive officers from matching those of larger companies in the oil and gas industry. The Compensation and Governance Committee does believe, however, that performance-based compensation plans are an important element in the compensation packages for the Corporation's executive officers, and that long-term equity interests, in the form of Options, compensate for lower base salaries. This compensation strategy is similar to the strategies of many other companies in the Corporation's peer group.

In setting base compensation levels of individual executive officers, consideration is given to objective factors such as level of responsibility, experience and expertise, as well as subjective factors such as leadership. Base salaries paid to executive officers of the Corporation, including the CEO, are set to be competitive with industry levels relative to the Corporation's peer group. Salaries of executive officers, including that of the CEO, are reviewed annually.

The salaries of the Named Executive Officers for 2015 were initially set at (i) \$230,000 for Mr. Ingram Gillmore, President and Chief Executive Officer; (ii) \$205,000 for Mr. David Hwang, Vice President, Finance and Chief Financial Officer; (iii) \$195,000 for Mr. Jason Kaluski, Vice President, Operations; (iv) \$185,000 for Mr. Yvan Chretien, Vice President, Land; and (v) \$195,000 for Mr. Bryan Dozzi, Vice President, Engineering (effective as of June 30, 2015 upon Mr. Dozzi's appointment to the position of Vice President, Engineering). However, due to the continued weakness and volatility of the oil and gas industry and the resultant weak commodity prices, in late 2015 management and the Board took steps to reduce general and administrative expenses in an effort to reduce indebtedness of the Corporation. As a result, management and the Board implemented salary cuts across the Corporation with bigger percentage cuts to the salaries of the Named Executive Officers and other senior staff relative to the salary cuts of more junior staff. Effective October 1, 2015, the base salaries of the Named Executive Officers were reduced to (i) \$201,500 for Mr. Ingram Gillmore, President and Chief Executive Officer; (ii) \$181,500 for Mr. David Hwang, Vice President, Finance and Chief Financial Officer; (iii) \$173,500 for Mr. Jason Kaluski, Vice President, Operations; (iv) \$165,500 for Mr. Yvan Chretien, Vice President, Land; and (v) \$173,500 for Mr. Bryan Dozzi, Vice President, Engineering. In addition to salary reductions, Named Executive Officers and other employees of the Corporation were given the option throughout 2015 to take days off without pay.

Bonuses

The Corporation has a discretionary bonus plan and the basis of awarding bonuses was approved by the Compensation and Governance Committee. The discretionary bonus plan is structured to drive and reward current year results. It is the Compensation and Governance Committee's philosophy that the total amount of bonuses paid should be tied primarily to the Corporation's performance, and rewarded to individuals relative to their performance of their duties and for their contribution to the achievement of the Corporation's annual goals and objectives. The Committee reviews the factors mentioned above relative to peer companies, in order to determine whether a bonus is in fact warranted. The amount of the bonus paid is linked to actual reserves value created, amongst other factors and is approved by the Board based upon the recommendations of the Compensation and Governance Committee. No bonuses were awarded to the Named Executive Officers in respect of 2015 performance.

Long-Term Incentive Compensation

Share Option Plan

The Corporation has the Option Plan, which permits the granting of Options to officers, directors, employees and consultants to the Corporation and its subsidiaries, and other persons who provide ongoing management and consulting services to the Corporation and its subsidiaries.

Options are granted by the Board on the recommendation of senior management, in the case of employees, and by the Compensation and Governance Committee, in the case of executive officers including the CEO. Options are intended to encourage retention and provide incentive, thereby aligning employee and shareholder interests by attempting to create a direct link between compensation and shareholder return. In addition, the Option Plan provides the opportunity for executive officers to develop and maintain a significant ownership position in the Corporation. By allowing participation in the Option Plan, the Corporation is able to reward overall corporate performance year over year. As with most companies in the Corporation's peer group, Options form an important part of the total compensation provided to the Corporation's executive officers as Options help compensate for lower base salaries relative to larger companies in the oil and gas industry.

Options are normally awarded by the Board upon the commencement of employment with the Corporation, based on the level of responsibility within the Corporation. Additional grants may be made periodically to ensure that the number of Options granted to any particular individual is commensurate with the individual's level of ongoing responsibility within the Corporation. When determining Options to be allocated to each individual executive officer, a number of factors are considered including the number of outstanding Options held by such executive officer, Options held by the executive officer that have been exercised or that have expired since the last grant to such executive officer, the value of such Options held by the executive officer and the total number of available Options for grant.

During the year ended December 31, 2015, the Corporation granted an aggregate of 2,607,532 Options to officers, directors, employees and consultants and as at the date hereof: (i) the Corporation has 6,458,573 Options outstanding, pursuant to which 6,458,573 Common Shares would be issuable upon exercise; and (ii) there remain 2,089,800 Options available for grant, pursuant to which 2,089,800 Common Shares would be issuable upon exercise, which in aggregate represents 10% of the currently outstanding Common Shares.

The Option grants during the year ended December 31, 2015 included grants to executive officers of 1,206,097 Options. Mr. Ingram Gillmore, President and CEO of the Corporation, received a relatively larger grant of Options during the year ended December 31, 2015 as a result of the expiry of 400,000 unexercised Options held by Mr. Gillmore during the year.

The maximum number of Common Shares that may be issued under the Option Plan at any time shall not exceed 10% of the aggregate number of Common Shares actually outstanding at that time, as determined on a non-diluted basis.

Summary

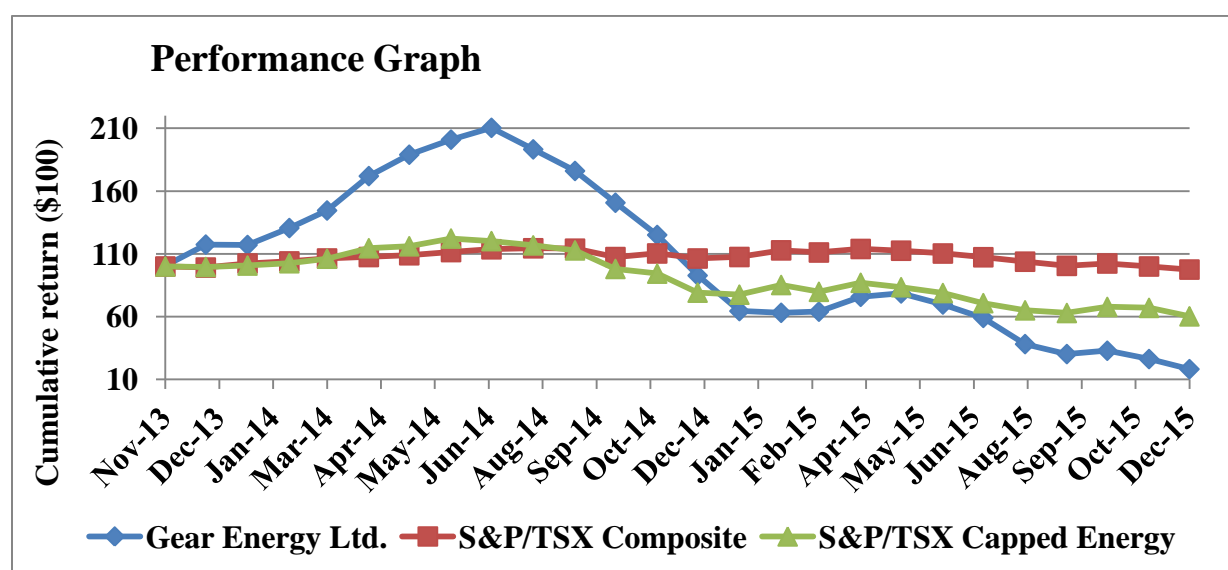
The Corporation's compensation policies have allowed the Corporation to attract and retain a team of motivated professionals and support staff working towards the common goal of enhancing shareholder value. The Compensation and Governance Committee and the Board will continue to review compensation policies to ensure that they are competitive within the oil and natural gas industry and consistent with the performance of the Corporation.

Risk Adjusted Compensation

As part of its review of the Corporation's compensation program, the Compensation and Governance Committee considered whether the compensation program provided executive officers of the Corporation with adequate incentives to achieve both short and long term objectives without motivating them to take inappropriate or excessive risk. The Compensation and Governance Committee concluded that the compensation program and policies of the Corporation did not encourage its NEOs to take inappropriate or excessive risks. This assessment is based on a number of considerations including, without limitation, the following: (a) the terms of the Option Plan provide that Options vest over a period of 3 years and expire on the fifth anniversary from the date of grant, which encourages executive officers to continue to develop favorable results over a longer period of time and reduces the risk of actions that may have short term advantages; (b) a portion of executive compensation in the form of bonuses is not guaranteed and is variable, year over year, as the Board has discretion to pay bonuses to NEOs based on recommendations made by the Compensation and Governance Committee, whose recommendations are based on internal corporate, administrative, operating and financial and reserve addition performance; (c) the Corporation's compensation program for certain executive officers is not structured significantly differently from the compensation program for other executive officers within the Corporation; and (d) the overall compensation program is market based and aligned with the Corporation's business plan and long-term strategies.

Performance Graph

The following graph compares the change in the cumulative total shareholder return since November 18, 2013 (the date the Common Shares commenced trading on the TSX), of a \$100 investment in the Common Shares, with the cumulative total return of the S&P/TSX Capped Energy Index and the S&P/TSX Composite Index for the comparable period.



As the Common Shares commenced trading on the TSX on November 18, 2013, the trend shown in the above graph does not provide a meaningful comparison to the trend in the Corporation's compensation paid to the Corporation's Named Executive Officers. As Options form a significant portion of compensation, the total compensation for the

Named Executive Officers is affected by increases and decreases in the price of the Common Shares as the value of such Options decrease as the Common Share price decreases.

Incentive Plan Awards

Option Plan

The Option Plan limits the number of Common Shares that may be subject to Options granted and outstanding under the Option Plan, and any other share compensation arrangements established by the Corporation, at any time to 10% of the outstanding Common Shares.

On April 11, 2016, the Option Plan Amendments were approved by the Board to (i) restrict the aggregate number of Common Shares that may be issued to non-management directors pursuant to the exercise of Options awarded under the Option Plan to a maximum of 1% of the Common Shares outstanding from time to time and to restrict the aggregate value of Options that may be granted to any one non-management director in any one year period to a maximum of \$100,000; (ii) amend the amending provision of the Option Plan to restrict the Board's ability to increase the maximum number of Options that may be granted to non-management directors without Shareholder approval; (iii) amend the change of control provision of the Option Plan to provide that the vesting of Options upon a change of control would only occur if the grantee it terminated in connection with such change of control or voluntary resigns within 6 months of such change of control for "Good Reason" (as such term is defined in the Option Plan); and (iv) to make certain other minor housekeeping amendments.

As described under the heading "*Matters to be Acted Upon at the Meeting – Approval of Option Plan Amendments and Unallocated Options*", the amendment to the amending provision of the Option Plan requires the approval of Shareholders at the Meeting pursuant to the terms of the Option Plan.

Options granted pursuant to the Option Plan have a term as determined by the Board and vest in such manner as determined by the Board. Options which expire during a blackout period (as defined in the Option Plan) or within nine business days following the expiration of a blackout period, shall be extended for a period of ten business days after the end of such blackout period. Options granted under the Option Plan are non assignable. The exercise price of Options granted is determined by the Board at the time of grant and, if at such time the Common Shares are listed on a stock exchange, the weighted average trading price per Common Share on an a stock exchange, for the last five (5) consecutive trading days immediately prior to the date of grant or such other minimum price that may be prescribed by such exchange.

The Option Plan provides that the number of Common Shares issuable under the Option Plan and all other security based compensation arrangements of the Corporation may not exceed 10% of the total number of issued and outstanding Common Shares from time to time. The number of Common Shares that may be issued under the Option Plan are subject to the following additional limitations: (i) the number of Common Shares reserved for issuance at any time, pursuant to the Option Plan and all other established or proposed share compensation arrangements of the Corporation, to Insiders (as defined in the Option Plan) of the Corporation shall not exceed 10% of the outstanding Common Shares and the number of Common Shares issued within one year, pursuant to the Plan and all other established or proposed share compensation arrangements of the Corporation, to any one Insider and such Insider's associates shall not exceed 10% of the outstanding Common Shares; and (ii) the aggregate number of Common Shares that may be reserved for issuance pursuant to the exercise of Options awarded to Non-Management Directors (as defined in the Option Plan) under the Option Plan shall not exceed 1% of the Common Shares

outstanding from time to time and the aggregate value of Options granted to any one Non-Management Director in any one year period shall not exceed \$100,000.

In case of death of an optionee, Options terminate on the date determined by the Board which may not be more than 12 months from the date of death and, if the optionee ceases to be a director, officer or employee of, or to provide ongoing management or consulting services to, the Corporation, Options terminate on the expiry of a period not in excess of six months as determined by the Board at the time of grant. In each case, the optionee is entitled to exercise those Options that the optionee was entitled to exercise on the date of death or the date the optionee ceased to be an officer, director or employee of, or to provide ongoing management or consulting services to, the Corporation, as the case may be. An optionee may make an offer ("**Surrender Offer**") to the Corporation, at any time, for the disposition and surrender by the optionee to the Corporation of any Options granted for an amount in cash or in Common Shares equal to the difference between the fair market value of the Common Shares underlying the Options (if Common Shares are listed on a stock exchange, fair market value will be the weighted average trading price per Common Share on a stock exchange, for the last five (5) consecutive trading days immediately prior to the date of grant or such other minimum price that may be prescribed by such exchange) and the exercise price of such Options and the Corporation may, but is not obligated to, accept the Surrender Offer.

If approved by the Board, Options may provide that, whenever the shareholders receive a take-over proposal (a "**Take-over Proposal**"), such Option may be exercised as to all or any of the Common Shares in respect of which such Option has not previously been exercised (including in respect of Common Shares not otherwise vested at such time) by the Optionee, but any such Option not otherwise vested and deemed only to have vested in accordance with the foregoing may only be exercised for the purposes of tendering to such Take-over Proposal.

The Board may make certain amendments to the Option Plan or discontinue the Option Plan at any time without the consent of the participants as permitted by the provisions of the Option Plan and, if required, subject to the approval by any exchange on which the Common Shares are listed. However, the Board may not amend the Option Plan without Shareholder approval with respect to: (i) increasing the number of Common Shares reserved for issuance under the Option Plan or the Option Plan maximum; (ii) reduce the exercise price of any Options granted; (iii) extend the expiry date of any outstanding Options other than as permitted in the Option Plan; (iv) permit a holder of Options to transfer or assign Options to a new beneficial holder, other than for estate settlement purposes; (v) any amendment to increase the number of Common Shares that may be issued to insiders above the restrictions contained in the Option Plan; or (vi) any amendments to the amendments section of the Option Plan. Additionally, if Shareholders approve the amendment to the amending provision of the Option Plan at the Meeting, the Board's ability to increase the maximum number of Options that may be granted to non-management directors without Shareholder approval will also require Shareholder approval. Other than as listed above, the Corporation may make such amendments to the Option Plan and any Options granted thereunder without the approval of Shareholders in accordance with the provisions of the Option Plan.

Pension Plan Benefits

The Corporation does not have a pension plan or similar benefit program.

Termination and Change of Control Benefits

The Corporation has entered into executive employment agreements (the "**Employment Agreements**") with each of the NEOs. The Employment Agreements continue indefinitely until terminated in accordance with the terms thereof and the annual salary payable thereunder is subject to annual review. NEOs are entitled to participate in any benefit plans adopted by the Corporation.

The Employment Agreements may be terminated by the Corporation for just cause at any time without any payment, other than salary owing for services rendered up to and including the last day of employment and outstanding vacation pay. The Corporation may terminate an Employment Agreement without just cause upon paying the NEO all salary earned but not paid to the termination date, all vacation pay due and owing to such date and a retiring allowance (as calculated in accordance with the Employment Agreements) of the sum of:

For the CEO:

- (i) one (1) year of the CEO's annual base salary as at the Cessation Date (as defined in the CEO's Employment Agreement); and
- (ii) an amount equal to the bonus amounts, if any, paid in the twelve (12) month period immediately preceding the Cessation Date.

For all other NEOs except Mr. Bryan Dozzi:

- (iii) six (6) months of the NEO's annual base salary as at the Cessation Date (as defined in the Employment Agreements) plus three months for every completed year of service after January 1, 2010, to a maximum of 12 months; and
- (iv) an amount equal to one half (1/2) the bonus amounts, if any, paid to the NEO in the twelve (12) month period immediately preceding the Cessation Date.

For Mr. Bryan Dozzi:

- (i) six (6) months of Mr. Dozzi's Annual Base Salary as at the Cessation Date plus three months for every completed year of service after May 1, 2014, to a maximum of 12 months; and

- (ii) an amount equal to one half (1/2) the bonus amounts, if any, paid to the NEO in the twelve (12) month period immediately preceding the Cessation Date.

In addition, a NEO may terminate his or her Employment Agreement within six (6) months following the occurrence of a change of control if there is an event which constitutes "Good Reason" as defined in the Employment Agreement, which includes: material adverse change, by the Corporation and without the agreement of the NEO, in the NEO's salary, title or lines of reporting, or the requirement that the NEO be based anywhere other than the Corporation's Calgary office on a normal and regular basis, such that immediately after such change or series of changes, the responsibilities and status of the NEO, taken as a whole, are not at least substantially equivalent to those assigned to the NEO immediately prior to such change, or any reason which would constitute constructive dismissal, in which case the NEO shall also be entitled to the termination payments outlined above. In exchange for payment of the retiring allowance, the NEO agrees to provide a release in an agreed upon form. Pursuant to the terms of the Employment Agreements, the NEOs recognize their obligation not to disclose confidential information and to refrain from using such information for purposes other than authorized by the Corporation both during and after termination of employment.

If the Employment Agreements were terminated by the Corporation, other than for just cause or by the respective NEOs for Good Reason following a change of control, at December 31, 2015, the aggregate amount payable thereunder would have been \$961,250. Under the terms of the Option Plan, as at December 31, 2015, Options only accelerate vesting at the discretion of the Board in the event of an Asset Sale or Take-over Proposal such amounts have not been included in payments to be made upon a change of control (see "*Statement of Executive Compensation – Directors' Incentive Plan – Incentive Plan Awards – Option Plan*"). Director Compensation

The annual fees to be paid to independent members of the Board in 2015 were as follows: (i) \$25,000 per year to each director as a base director fee; (ii) \$8,000 per year as an additional fee for the chair of the Audit Committee; (iii) \$5,000 per year as an additional fee for the chair of the Reserves Committee; (iv) \$4,000 per year as an additional fee for the chair of the Compensation and Governance Committee; and (v) \$15,000 per year as an additional fee for the chairman of the Board (collectively, the "**Board Member Fees**"); however, one half of the

applicable Board Member Fee is tied to the price performance of the Common Shares in the given year based on the volume weighted average price of the Common Shares on the TSX for the last 10 trading days prior to the applicable year end as compared to the volume weighted average price of the Common Shares on the TSX for the last 10 trading days of the prior year. As a result of the price performance of the Common Shares in 2015, the one-half of the Board Member Fees subject to reduction were reduced by 80%.

Board members are also eligible to participate in the Option Plan and any other long term compensation plans adopted by the Corporation from time to time. The Corporation will reimburse directors for all reasonable expenses incurred in order to attend meetings. The number of Options awarded to directors will be determined by criteria to be established by the Compensation and Governance Committee. The Option grants during the year ended December 31, 2015 included grants to directors of 439,005 Options. Mr. Don Gray received a relatively larger grant of Options during the year ended December 31, 2015 as a result of the expiry of 222,600 unexercised Options held by Mr. Gray during the year.

As noted under "*Matters to be Acted upon at the Meeting - Approval of Unallocated Options*", the Board recently amended the terms of the Option Plan to provide that the aggregate number of Common Shares that may be reserved for issuance pursuant to Options granted to non-management directors under the Option Plan shall not exceed 1% of the Common Shares outstanding from time to time and the aggregate value of Options granted to any one non-management director in any one year period shall not exceed \$100,000. The Board will not be able to amend the limits on the number of Options issuable to non-management directors without the approval of the Shareholders.

While the Corporation does not currently have a formal orientation and education program for new recruits to the Board, the Corporation has historically provided such orientation and education on an informal basis. As new directors join the Board, management will provide these individuals with corporate policies, historical information about the Corporation, as well as information on the Corporation's performance and its strategic plan with an outline of the general duties and responsibilities entailed in carrying out their duties. The Board believes that these procedures will prove to be a practical and effective approach in light of the Corporation's particular circumstances, including the size of the Corporation, limited changes to members of the Board and the experience and expertise of the members of the Board. The Compensation and Governance Committee has the responsibility and duty to work with management of the Corporation to facilitate an education and comprehensive orientation program for new members of the Board and a continuing education program for all directors.

Presentations are made regularly to the Board and committees to educate and inform them of changes within the Corporation and on appropriate other subjects such as regulatory and industry requirements and standards, capital markets, commodity pricing and corporate governance. Historically, the Audit Committee has quarterly presentations on emerging trends and issues in the accounting and audit fields from management. During the year ended December 31, 2015, the auditor of the Corporation was present at all audit committee meetings in which financial statements were recommended for approval by the Audit Committee. The Board has quarterly presentations on operational results and technical and regulatory issues pertaining to reserves evaluation from management and the independent reserves evaluator is present at a minimum of one of the Board meetings each year. Management provides the Board with an annual update on corporate governance "best practices" from third party publications as well as quarterly reports on new legislation or regulation relating to health, safety and environmental matters.

The Corporation also encourages the directors to attend, enrol or participate in courses and/or seminars dealing with financial literacy, corporate governance and related matters and has agreed to pay the cost of such courses and seminars. Each director of the Corporation has the responsibility for ensuring that he maintains the skill and knowledge necessary to meet his obligations as a director. The Compensation and Governance Committee has the responsibility and duty to work with management of the Corporation to facilitate an education and comprehensive orientation program for new members of the Board and a continuing education program for all directors.

The Corporation has adopted a Code of Business Conduct and Ethics (the "**Code**") for directors, officers, employees and contractors of the Corporation. - review and recommend a compensation philosophy, guidelines and plans for the Corporation's executives and employees;
- review and approve corporate goals and objectives relevant to CEO compensation;
- evaluate the CEO's performance in light of those goals, and make recommendations to the Board with regard to the CEO's compensation based on this evaluation;
- in consultation with the CEO, review and approve all executive compensation (including that of the CEO), incentive-compensation plans and equity-based plans;

- review and approve fees to be paid to members of the Board;
- review executive compensation disclosure before it is publicly disclosed; and
- be the forum for meetings of all independent directors of the Corporation.

The Compensation and Governance Committee is required to be comprised of at least three directors, or such greater number as the Board may determine from time to time. All members of the Compensation and Governance Committee are required to be independent, as such term is defined for this purpose under applicable securities law requirements. Pursuant to the mandate and terms of reference of the Compensation and Governance Committee, meetings of the Compensation and Governance Committee are to take place regularly in each year on such dates and at such locations as the Chair of the Compensation and Governance Committee shall

determine and may also meet at any other time or times on the call of the Chair of the Compensation and Governance Committee or any two of the other members.

In addition to the Audit Committee and the Compensation and Governance Committee, the Corporation has established a Reserves Committee. The Reserves Committee is comprised entirely of independent directors.

The Reserves Committee is responsible for various matters relating to reserves of the Corporation that may be delegated to the Reserves Committee pursuant to National Instrument 51-101 – *Standards of Disclosure for Oil and Gas Activities*, including:

- reviewing the Corporation's procedures relating to the disclosure of information with respect to oil and gas activities, including reviewing its procedures for complying with disclosure requirements and restrictions set forth under applicable securities law requirements;
- reviewing the Corporation's procedures for providing information to the independent evaluator;
- meeting, as considered necessary, with management and the independent evaluator to determine whether any restrictions placed by management affect the ability of the evaluator to report without reservation on the reserves information and data (the "**Reserves Data**") and to review the Reserves Data and the report of the independent evaluator thereon (if such report is provided);
- reviewing the appointment of the independent evaluator and, in the case of any proposed change to such independent evaluator, determining the reason therefor and whether there have been any disputes with management;
- providing a recommendation to the Board as to whether to approve the content or filing of the statement of the Reserves Data and other information that may be prescribed by applicable securities law requirements including any reports of the independent engineer and of management in connection therewith;
- reviewing the Corporation's procedures for reporting other information associated with oil and gas producing activities;
- health, safety and environmental matters; and
- generally reviewing all matters relating to the preparation and public disclosure of estimates of the Corporation's reserves.

The Board assesses the effectiveness of the Board, its committees and the effectiveness and contributions of individual directors by way of an annual written questionnaire distributed to each Board member. The Board also satisfies itself with respect to the effectiveness of the Board, its committees and individual directors by monitoring, on an informal basis, whether the objectives of each of the Board and the Corporation are being achieved and whether the responsibilities of each of the Board, its committees, its individual directors and the Corporation are being fulfilled.

10. **Director Term Limits and Other Mechanisms of Board Renewal**

The Board does not believe that fixed term limits or mandatory retirement ages are in the best interest of the Corporation. Therefore it has not specifically adopted term limits or other mechanisms for board renewal.

However, when considering nominees for the Board, the Compensation and Governance Committee reviews the skills and experience of the current directors of the Corporation to assess whether the Board's skills and experience need to be strengthened in any area. In addition to considering the skills and experience of the Board, the Compensation and Governance Committee also assesses the knowledge and character of all nominees to the Board and other factors such as independence of the directors to ensure that the Board is operating effectively and independently of management. The Compensation and Governance Committee considers both the term of service and age of individual directors, the average term of the Board as a whole and turnover of directors over the prior years when proposing nominees for election of the directors of the Corporation. The Compensation and Governance Committee considers the benefits of regular renewal in the context of the needs of the Board at the time and the benefits of the institutional knowledge of the Board members.

11. **Policies Regarding the Representation of Women on the Board**

The Board has not adopted any policies that address the identification and nomination of women directors of the Corporation.

The Board believes that Board nominations and executive officer appointments should be made on the basis of the skills, knowledge, experience and character of individual candidates and the requirements of the Board and management at the time. The Corporation is committed to a meritocracy and believes that considering the broadest group of individuals who have the skills, knowledge, experience and character required to provide leadership needed to achieve our business objectives, without reference to their age or gender is in the best interests of the Corporation and all of its stakeholders.

12. **Consideration of the Representation of Women in the Director Identification and Selection Process**

As a result of the Corporation's commitment to meritocracy, the level of representation of women on the Board is not considered in identifying and nominating candidates for election or re-election to the Board; however, the Board encourages the consideration of women who have the necessary, skills, knowledge, experience and character when considering new potential candidates for the Board.

13. **Consideration Given to the Representation of Women in Executive Officer Appointments**

As a result of the Corporation's commitment to meritocracy the level of representation of women in executive officer positions is not considered when making executive officer appointments; however, the Board encourages the consideration of women who have the necessary, skills, knowledge, experience and character when considering new potential candidates for executive officer positions.

14. **Issuer's Targets Regarding the Representation of Women on the Board and in Executive Officer Positions**

The Corporation has not imposed quotas or targets regarding the representation of women on the Board and in executive officer positions. The Board believes that imposing quotas or targets regarding the representation of women in executive officer positions would compromise the principles of meritocracy.

15. **Number of Women on the Board and in Executive Officer Positions**

There are presently no women (0%) serving on the Board and no women (0%) serving in executive officer positions at the Corporation.

MANDATE OF THE BOARD OF DIRECTORS

GENERAL

The Board of Directors (the "**Board**") of Gear Energy Ltd. (the "**Corporation**" or "**Gear**") is responsible for the stewardship of the Corporation. In discharging its responsibility, the Board will exercise the care, diligence and skill that a reasonably prudent person would exercise in comparable circumstances and will act honestly and in good faith with a view to the best interests of Gear. In general terms, the Board will:

- in consultation with the chief executive officer of the Corporation (the "**CEO**"), define the principal objectives of Gear;
- supervise the management of the business and affairs of Gear with the goal of achieving Gear's principal objectives as developed in association with the CEO;
- discharge the duties imposed on the Board by applicable laws; and
- for the purpose of carrying out the foregoing responsibilities, take all such actions as the Board deems necessary or appropriate.

SPECIFIC

The Board will also have the following responsibilities:

Executive Team Responsibility

- Appoint the CEO and senior officers, approve their compensation, and monitor the CEO's performance against a set of mutually agreed corporate objectives directed at maximizing shareholder value.
- In conjunction with the CEO, develop a clear mandate for the CEO, which includes a delineation of management's responsibilities.
- Establish processes as required that adequately provides for succession planning, including the appointing, training and monitoring of senior management.
- Establish limits of authority delegated to management.

Operational Effectiveness and Financial Reporting

- Annual review and adoption of a strategic planning process and approval of Gear's strategic plan, which takes into account, among other things, the opportunities and risks of the business.
- Establish or cause to be established systems to identify the principal risks to Gear and that the best practical procedures are in place to monitor and mitigate the risks.
- Consider or cause to be considered the implications of risk associated with Gear's compensation policies and practices.

- Endeavour to establish or cause to be established processes to address applicable regulatory, corporate, securities and other compliance matters.
- Establish or cause to be established an adequate system of internal control and management information systems.
- Establish or cause to be established due diligence processes and appropriate controls with respect to applicable certification requirements regarding Gear's financial and other disclosure.
- Review and approve Gear's financial statements and oversee Gear's compliance with applicable audit, accounting and reporting requirements.
- Approve annual operating and capital budgets.
- Review and consider for approval all amendments or departures proposed by management from established strategy, capital and operating budgets.
- Review operating and financial performance results relative to established strategy, budgets and objectives.

Integrity/Corporate Conduct

- Establish a communications policy or policies to ensure that a system for corporate communications to all stakeholders exists, including processes for consistent, transparent, regular and timely public disclosure, and to facilitate feedback from stakeholders.
- Approve a Business Conduct & Ethics Practice for directors, officers and employees and monitor compliance with the Practice and approve any waivers of the Practice for officers and directors.
- To the extent feasible, satisfy itself as to the integrity of the CEO and other executive officers of the Corporation and that the CEO and other executive officers create a culture of integrity throughout Gear.

Board Process/Effectiveness

- Endeavour to ensure that Board materials are distributed to directors in advance of regularly scheduled meetings to allow for sufficient review of the materials prior to the meeting. Directors are expected to attend all meetings.
- Engage in the process of determining Board member qualifications with the Corporate Governance Committee including ensuring that a majority of directors, including the Chairman of the Board, qualify as independent directors pursuant to National Instrument 58-101 Disclosure of Corporate Governance Practices (as implemented by the Canadian Securities Administrators and as amended from time to time) and that the appropriate number of independent directors are on each committee of the Board as required under applicable securities rules and requirements.
- Approve the nomination of directors.
- Provide or cause to be provided a comprehensive orientation to each new director.
- Establish an appropriate system of corporate governance including practices to ensure the Board functions independently of management.
- Establish appropriate practices for the regular evaluation of the effectiveness of the Board, its committees and its members.

- Establish committees and approve their respective mandates and the limits of authority delegated to each committee.
- Review and re-assess the adequacy of the mandate of the committees of the Board on a regular basis, but not less frequently than on an annual basis.
- Review the adequacy and form of the directors' compensation to ensure it realistically reflects the responsibilities and risks involved in being a director.

Each member of the Board is expected to understand the nature and operations of Gear's business, and have an awareness of the political, economic and social trends prevailing in all countries or regions in which Gear operates, or is contemplating potential operations.

Independent directors shall meet regularly, and in no case less frequently than quarterly, without non-independent directors and management participation.

The Board may retain persons having special expertise and may obtain independent professional advice to assist it in fulfilling its responsibilities at the expense of the Corporation, as determined by the Board.

In addition to the above, adherence to all other Board responsibilities as set forth in the Corporation's By-Laws, applicable policies and practices and other statutory and regulatory obligations, such as issuance of securities, etc., is expected.

DELEGATION

The Board may delegate its duties to, and receive reports and recommendations from, any committee of the Board.

Subject to terms of the Disclosure, Confidentiality and Trading Policy and other policies and procedures of Gear, the Chairman of the Board will act as a liaison between stakeholders of Gear and the Board (including independent members of the Board).

STANDARDS OF LIABILITY

Nothing contained in this mandate is intended to expand applicable standards of liability under statutory, regulatory, common law or any other legal requirements for the Board. The Board may adopt additional policies and procedures as it deems necessary from time to time to fulfill its responsibilities.

AMENDED SHARE OPTION PLAN

1. Purpose of Plan

The purpose of this plan is to develop the interest of officers, directors, employees of, consultants to, Gear Energy Ltd. and its subsidiaries or persons providing services on an ongoing basis thereto in the growth and development of the Corporation and its subsidiaries by providing them with the opportunity through options to acquire an increased proprietary interest in the Corporation.

2. Defined Terms

Where used herein, the following terms shall have the following meanings, respectively:

- (a) **"Board"** means the board of directors of the Corporation;
- (b) **"business day"** a day other than a Saturday, Sunday or other than a day when banks in the City of Calgary, Alberta are generally not open for business;
- (c) **"Change of Control"** means:
 - (i) the sale to a person or acquisition by a person not affiliated with the Corporation or its subsidiaries of net assets of the Corporation or its subsidiaries having a value greater than 50% of the fair market value of the net assets of the Corporation and its subsidiaries determined on a consolidated basis prior to such sale whether such sale or acquisition occurs by way of reconstruction, reorganization, recapitalization, consolidation, amalgamation, arrangement, merger, transfer, sale or otherwise; or
 - (ii) any change in the holding, direct or indirect, of shares of the Corporation by a person not affiliated with the Corporation as a result of which such person, or a group of persons, or persons acting in concert, or persons associated or affiliated with any such person or group within the meaning of the *Business Corporations Act* (Alberta), are in a position to exercise effective control of the Corporation whether such change in the holding of such shares occurs by way of takeover bid, reconstruction, reorganization, recapitalization, consolidation, amalgamation, arrangement, merger, transfer, sale or otherwise if members of the Board who are members of the Board immediately prior to the earlier of such change and the first public announcement of such change cease to constitute a majority of the Board at any time within sixty days of such change; and for the purposes of this Plan, a person or group of persons holding shares or other securities in excess of the number which, directly or following conversion thereof, would entitle the holders thereof to cast 50% or more of the votes attaching to all shares of the Corporation which, directly or following conversion of the convertible securities forming part of the holdings of the person or group of persons noted above, may be cast to elect directors of the Corporation shall be deemed, other than a person holding such shares or other securities in the ordinary course of business as an investment manager who is not using such holding to exercise effective control, to be in a position to exercise effective control of the Corporation;

- (iii) the winding up or liquidation of the Corporation or the sale, lease or transfer of all or substantially all of the directly or indirectly held assets of the Corporation to any other person or persons (other than pursuant to an internal reorganization or in circumstances where the business of the Corporation is continued and where the shareholdings or other securityholdings, as the case may be, in the continuing entity and the constitution of the board of directors or similar body of the continuing entity is such that the transaction would not be considered a "Change of Control" if paragraph (c)(ii) above was applicable to the transaction);
- (d) "**Common Shares**" means the common shares of the Corporation or, in the event of an adjustment contemplated by Section 12 or 13 hereof, such other securities to which an Optionee may be entitled upon the exercise of an Option as a result of such adjustment;
- (e) "**Corporation**" means Gear Energy Ltd., and includes any successor corporation thereof;
- (f) "**Exchange**" means the Toronto Stock Exchange or, if the Common Shares are not then listed and posted for trading on the Toronto Stock Exchange, on such stock exchange in Canada on which such shares are listed and posted for trading as may be selected for such purpose by the Board;
- (g) "**Good Reason**" means any materially adverse change by the Corporation without the agreement of an Optionee, in any of the Optionee's duties, powers, rights, salary, title or lines of reporting, such that immediately after such change or series of changes, the responsibilities and status of such Optionee, taken as a whole, are fundamentally diminished compared to those assigned to the Optionee immediately prior to such change or series of changes, or any other reason that would be considered to amount to constructive dismissal by a court of competent jurisdiction in Alberta;
- (h) "**Holder**" means a person, a group of persons or persons acting jointly or in concert, or persons associated or affiliated, within the meaning of the *Securities Act* (Alberta), with any such person, group of persons or any of such persons acting jointly or in concert;
- (i) "**associate**" has the meaning set forth in the *Securities Act* (Alberta);
- (j) "**Insider**" has the meaning set forth in the applicable rules of the Exchange for this purpose;
- (k) "**Market Price**" means, as at any date when the Market Price is to be determined, the volume weighted average trading price per Common Share on an Exchange, for the last five (5) consecutive trading days immediately prior to the date of determination, provided that if the Common Shares are not then listed and posted for trading on an Exchange, then the Market Price shall be determined by the Board in its sole discretion acting reasonably and in good faith;
- (l) "**Non-Management Director**" means a director of the Corporation who is not also an employee of or consultant of the Corporation or its subsidiaries;
- (m) "**Options**" means options to purchase Common Shares granted pursuant to the provisions hereof;
- (n) "**Optionees**" means persons to whom Options are granted and which such Options, or a portion thereof, remain unexercised;
- (o) "**Plan**" means this share option plan of the Corporation, as the same may be amended or varied from time to time;
- (p) "**Participants**" means directors, officers, employees of, and consultants to, the Corporation or its subsidiaries and other Service Providers;

- (q) **"Service Provider"** means a person or company engaged by the Corporation or its subsidiaries to provide services for an initial, renewable or extended period of twelve months or more;
- (r) **"Shareholders"** means the holders of Common Shares;
- (s) **"Surrender Price"** means the Closing price of the Common Shares on the Exchange on the date the Options are surrendered to the Corporation in accordance with Section 10 or Section 11 hereof, as applicable, provided that if the Common Shares are not then listed and posted for trading on an Exchange, then the Surrender Price shall be determined by the Board in its sole discretion acting reasonably and in good faith; and
- (t) **"Take-over Proposal"** means any proposal or offer by a third party, whether or not subject to a due diligence condition and whether or not in writing, to acquire in any manner, directly or indirectly, beneficial ownership of or control or direction over more than 50% of the Corporation's outstanding voting shares whether by way of arrangement, amalgamation, merger, consolidation or other business combination, including any single or multi-step transaction or series of related transactions that is structured to permit such third person to acquire in any manner, directly or indirectly, more than 50% of its outstanding voting shares.

3. Administration

The Plan shall be administered by the Board. The Board may, from time to time, adopt such rules and regulations for administering the Plan as it may deem proper and in the best interests of the Corporation and may, subject to applicable law, delegate its powers hereunder to administer the Plan to a Committee of the Board. The Board may delegate to any committee of the Board any duties relating to the Plan as the Board may deem advisable, and where so delegated, any reference to the Board in this Plan shall be deemed to be a reference to such committee. In addition, the Board may delegate to one or more of its members or to one or more agents any duties as it may deem advisable, and the Board or any person to whom it has delegated duties as aforesaid may employ one or more persons to render advice with respect to any responsibility the Board or such person may have under the Plan.

4. Granting of Options

Subject to this Section 4, the Board may from time to time designate directors, officers, employees of, and consultants to, the Corporation or its subsidiaries and other Service Providers to whom Options may be granted and the number of Common Shares to be optioned to each, provided that the number of Common Shares to be optioned shall not exceed the limitations provided in Section 5 hereof.

5. Limitations to the Plan

Notwithstanding any other provision of the Plan:

- (a) unless otherwise approved by the Shareholders, the aggregate number of Common Shares that may be issued pursuant to the exercise of Options awarded under the Plan and all other share compensation arrangements of the Corporation is 10% of the Common Shares outstanding from time to time;
- (b) the number of Common Shares reserved for issuance at any time, pursuant to the Plan and all other established or proposed share compensation arrangements of the Corporation, to Insiders shall not exceed 10% of the outstanding Common Shares and the number of Common Shares issued within one year, pursuant to the Plan and all other established or proposed share compensation arrangements of the Corporation, to any one Insider and such Insider's associates shall not exceed 10% of the outstanding Common Shares; and

- (c) the aggregate number of Common Shares that may be reserved for issuance pursuant to the exercise of Options awarded to Non-Management Directors under the Plan shall not exceed 1% of the Common Shares outstanding from time to time and the aggregate value of Options granted to any one Non-Management Director in any one year period shall not exceed \$100,000.

In determining the number of Common Shares issued within one year for the purposes of subclause (b) above, the number of Common Shares shall be determined on the basis of the number of Common Shares that are outstanding immediately prior to the Common Share issuance, excluding any Common Shares issued pursuant to share compensation arrangements of the Corporation over the preceding one-year period.

For the purposes of this Section 5 any increase in the issued and outstanding Common Shares (whether it is a result of exercise of Options, including under Section 11 hereof, or otherwise) will result in an increase in the number of Common Shares that may be issued on Options outstanding at any time and any increase in the number of Options granted will, upon exercise, make new grants available under the Plan.

Options that are cancelled, surrendered, terminated or expire prior to the exercise of all or a portion thereof shall result in the Common Shares that were reserved for issuance thereunder being available for a subsequent grant of Options pursuant to this Plan to the extent of any Common Shares issuable thereunder that are not issued under such cancelled, surrendered, terminated or expired Option.

6. Vesting of Options

The Board may, in its sole discretion, determine: (i) the time during which Options shall vest; (ii) the method of vesting; or (iii) that no vesting restriction shall exist. In the absence of any determination by the Board to the contrary, Options will vest and be exercisable as to one-third (1/3) of the total number of Common Shares subject to the Options on each of the first, second and third anniversaries of the date of grant (computed in each case to the nearest full share) (subject to acceleration of vesting at the discretion of the Board).

7. Option Price

The exercise price of Options granted under the Plan shall be fixed by the Board when such Option is granted, provided that if the Common Shares are listed on a stock exchange, the exercise price of the Options shall not be less than the Market Price or such other minimum price as may be required by the Exchange on which the Common Shares are listed at the time of grant.

8. Option Terms

The period during which an Option is exercisable shall, subject to the provisions of the Plan requiring or permitting acceleration of rights of exercise, be such period, as may be determined from time to time by the Board but subject to the rules of any stock exchange or other regulatory body having jurisdiction, and in the absence of any determination to the contrary will be five (5) years from the date of grant.

Should the expiry date of an Option fall within a Black Out Period (as defined below) or within nine business days following the expiration of a Black Out Period, such expiry date of the Option shall be automatically extended without any further act or formality to that date which is the tenth business day after the end of the Black Out Period, such tenth business day to be considered the expiry date for such Option for all purposes under the Plan. The ten business day period referred to in this paragraph may not be extended by the Board.

"Black Out Period" means the period during which the relevant Optionee is prohibited from exercising an Option due to trading restrictions imposed by the Corporation pursuant to any policy of the Corporation respecting restrictions on trading that is in effect at that time.

Each Option shall, among other things, contain provisions to the effect that the Option shall be personal to the Optionee and shall not be assignable. In addition, each Option shall provide that:

- (a) upon the death of the Optionee, the Option shall terminate on the date determined by the Board which shall not be more than twelve (12) months from the date of death; and
- (b) if the Optionee shall no longer be a director or officer of or be in the employ of, or consultant or other Service Provider to, either the Corporation or a subsidiary of the Corporation (other than by reason of death), the Option shall terminate on the expiry of the period (the "**Termination Date**") not in excess of six (6) months prescribed by the Board at the time of grant, following the date that the Optionee ceases to be a director or officer of, or an employee of or a consultant or other Service Provider to, either the Corporation or a subsidiary of the Corporation and, in the absence of any determination to the contrary, will be thirty (30) days following the date that the Optionee ceases to be a director or officer of, or an employee of or a consultant or other Service Provider to, the Corporation or any subsidiary of the Corporation;

provided that the number of Common Shares that the Optionee (or his or her heirs or successors) shall be entitled to purchase until such date of termination shall be the number of Common Shares which the Optionee was entitled to purchase on the date the Optionee ceased to be an officer, director, employee, consultant or other Service Provider, as the case may be.

The Plan does not confer upon an Optionee any right with respect to continuation of employment by the Corporation or any subsidiary thereof, nor does it interfere in any way with the right of the Optionee, the Corporation or a subsidiary thereof to terminate the Optionee's employment or service provision at any time.

Notwithstanding any other provisions contained herein, the Board may, in its sole discretion, accelerate the expiry date or shorten the time period within which Options shall be exercisable in connection with a Change of Control.

9. Exercise of Option

Subject to the provisions of the Plan, an Option may be exercised from time to time by delivery to the Corporation at its head office in Calgary, Alberta or such other place as may be specified by the Corporation, of a written notice of exercise specifying the number of Common Shares with respect to which the Option is being exercised and accompanied by payment in full of the exercise price unless such exercise is made in accordance with Article 10 or 11 hereof. The exercise price is payable in lawful money of Canada by cash, cheque, certified cheque, bankers' draft, wire transfer or such other manner of payment acceptable to the Corporation.

10. Exercise for Cash

Notwithstanding anything else contained herein, an Optionee may elect to surrender, in whole or in part, his or her rights under any Option by written notice given to the Corporation stating that such Optionee wishes to surrender his or her Option in exchange for a payment by the Corporation of a cash amount per Option equal to the difference (if positive) between the Surrender Price (as calculated on the date of surrender) and the exercise price of the Option. The Board has the sole discretion to consent to or reject the election of the Optionee to receive cash pursuant to this Section 10. If the Board disapproves of the election, such Optionee may (i) exercise the Option under Section 9 (read without reference to Section 10); (ii) provided that the Corporation has not rejected a request of such Optionee to exercise any Options pursuant to Section 11 in the previous six (6) months, exercise the Option under Section 11 (the

Board may still reject the Optionee's election to exercise pursuant to Section 11); or (iii) retract the request to exercise such Option.

11. Cashless Exercise

Notwithstanding anything else contained herein, an Optionee may elect to surrender, in whole or in part, his or her rights under any Option by written notice given to the Corporation stating that such Optionee wishes to surrender his or her Option in exchange for the issuance of Common Shares equal to the number determined by dividing the Surrender Price (calculated as at the date of surrender) into the difference (if positive) between the Surrender Price (calculated as at the date of surrender) and the exercise price. The Board has the sole discretion to consent to or reject the election of such Optionee to receive Common Shares pursuant to this Section 11. If the Board disapproves of the election, such Optionee may (i) exercise the Option under Section 9 (read without reference to Section 11); (ii) provided that the Corporation has not rejected a request of such Optionee to exercise any Options pursuant to Section 10 in the previous six (6) months, exercise the Option under Section 10 (the Board may still reject the Optionee's election to exercise pursuant to Section 10); or (ii) retract the request to exercise such Option.

12. Alterations in Shares

In the event, at any time or from time to time, that the share capital of the Corporation shall be consolidated or subdivided prior to the exercise by the Optionee, in full, of any Option in respect of all of the shares granted or the Corporation shall pay a dividend upon the Common Shares by way of issuance to the holders thereof of additional Common Shares, Options with respect to any shares which have not been purchased at the time of any such consolidation, subdivision or stock dividend shall be proportionately adjusted so that the Optionee shall from time to time, upon the exercise of an Option, be entitled to receive the number of shares of the Corporation the Optionee would have held following such consolidation, subdivision or stock dividend if the Optionee had purchased the shares and had held such shares immediately prior to such consolidation, subdivision or stock dividend. Upon any such adjustments being made, the Optionee shall be bound by such adjustments and shall accept the terms of such Options in lieu of the Options previously outstanding.

13. Mergers, Amalgamation and Sale

If the Corporation shall become merged (whether by plan of arrangement or otherwise) or amalgamated in or with another corporation or shall sell the whole or substantially the whole of its assets and undertakings for shares or securities of another corporation or other entity, the Corporation shall, subject to this Section 13, make provision that, upon exercise of an Option during its unexpired period after the effective date of such merger, amalgamation or sale, the Optionee shall receive such number of shares of the continuing successor corporation or other entity in such merger or amalgamation or the securities or shares of the purchasing corporation or other entity as the Optionee would have received as a result of such merger, amalgamation or sale if the Optionee had purchased the shares of the Corporation immediately prior thereto for the same consideration paid on the exercise of the Option and had held such shares on the effective date of such merger, amalgamation or sale and, upon such provision being made, the obligation of the Corporation to the Optionee in respect of the Common Shares subject to the Option shall terminate and be at an end and the Optionee shall cease to have any further rights in respect thereof.

14. Change of Control

In the circumstances where the Corporation has entered into an agreement relating to, or otherwise becomes aware of, a transaction which, if completed, would result in a Change of Control, the Corporation shall give written notice of the proposed transaction to the Participants, together with a description of the effect of such Change of Control on outstanding Options. Such notice shall be given not less than fifteen (15) Business Days prior to the closing of the transaction resulting in the Change of Control. Notwithstanding anything else in this Plan or any agreements entered into between the Corporation and each Optionee to whom an Option is granted hereunder to the contrary, the Board may, in connection with a Change of Control and at its sole option and without the consent of any Participant: (i) take such steps as

are necessary or desirable to cause the conversion or exchange or replacement of any outstanding Options into or for, rights or other securities of substantially equivalent value (or greater value), as determined by the Board in its discretion, in any entity participating in or resulting from a Change of Control; or (ii) accelerate the vesting of any or all outstanding Options to provide that such outstanding Options shall be fully vested upon (or immediately prior to) the completion of the transaction resulting in the Change of Control if: (a) the required steps, as determined by the Board in its discretion, are not being taken in connection with such Change of Control to cause the conversion or exchange or replacement of any outstanding Options into or for rights or other securities of substantially equivalent value (or greater value), as determined by the Board in its discretion, in any entity participating in or resulting from a Change of Control; or (b) the Corporation has entered into an agreement relating to a transaction which, if completed, would result in a Change of Control and the counterparty or counterparties to such agreement require that all outstanding Options will be either (x) exercised immediately before the effective time of such transaction, or (y) terminated on or after the effective time of such transaction.

Notwithstanding anything contained herein, in the event of any Change of Control prior to the Expiry Date of any outstanding Option: (i) an Optionee is terminated without cause in connection with such Change of Control or within the six (6) months following a Change of Control, all Options held by the Optionee shall vest and the Optionee shall, if such termination occurs prior to, or at, the effective time of such Change of Control, be entitled to exercise all Options held by the Optionee until immediately prior to the effective time of such Change of Control (or such other time as may be designated by the Board) and, if such termination period occurs following such Change of Control, the Optionee shall be entitled to exercise all Options held by such Optionee until the date that is 90 days after the Termination Date, all Options which have not been exercised prior to the required dates as set in this paragraph (i) shall become null and void and all rights to receive Common Shares thereunder shall be forfeited by the Optionee; or (ii) within six (6) months following a Change of Control, the Optionee voluntarily resigns for an event or events which constitute Good Reason, all Options held by the Optionee shall vest and the Optionee shall be entitled to exercise all Options held by such Optionee until the date that is 90 days after the Termination Date and after such date all Options which have not been exercised shall become null and void and all rights to receive common shares thereunder shall be forfeited by the Optionee.

The Board may, in its sole discretion, by Board resolution provide that, whenever the Corporation's Shareholders receive a Take-over Proposal, such Options may be exercised as to all or any of the Common Shares in respect of which such Option has not previously been exercised (including in respect of Common Shares not otherwise vested at such time) by the Participant (the "**Take-over Acceleration Right**"), but any such Option not otherwise vested and deemed only to have vested in accordance with the foregoing may only be exercised for the purposes of tendering to such Take-over Proposal. If for any reason any such Common Shares are not so tendered or, if tendered, are not, for any reason taken up and paid for by the offeree pursuant to the Take-over Proposal, any such Common Shares so purchased by the Participant shall be and shall be deemed to be cancelled and returned to the treasury of the Corporation, and shall be added back to the number of Common Shares, if any, remaining unexercised under the Option (and shall thus be available for exercise of the Option in accordance with the terms thereof) and upon presentation to the Corporation of share certificates representing such Common Shares properly endorsed for transfer back to the Corporation, the Corporation shall refund to the Participant all consideration paid by him or her in the initial purchase thereof. The Take-over Acceleration Right shall commence at such time as is determined by the Board, provided that, if the Board approves the Take-over Acceleration Right but does not determine commencement and termination dates regarding same, the Take-over Acceleration Right shall commence on the date of the Take-over Proposal and end on the earlier of the expiry time of the Option and the tenth (10th) day following the expiry date of the Take-over Proposal. Notwithstanding the foregoing, the Take-over Acceleration Right may be extended for such longer period as the Board may resolve.

15. No Rights as a Shareholder

An Optionee shall not have any of the rights or privileges of a shareholder of the Corporation in respect of any Common Shares issuable upon exercise of an Option until certificates representing such Common Shares have been issued and delivered.

16. Regulatory Authorities Approvals

The Plan shall be subject to the approval, if required, of any stock exchange on which the Common Shares are listed for trading. Any Options granted prior to such approval and after listing on any such stock exchange shall be conditional upon such approval being given and no such Options may be exercised unless such approval, if required, is given.

17. Option Agreements

A written agreement will be entered into between the Corporation and each Optionee to whom an Option is granted hereunder, which agreement will set out the number of Common Shares subject to Option, the exercise price, the vesting dates, circumstances when vesting of Options may be accelerated, the expiry date and any other terms approved by the Board, all in accordance with the provisions of this Plan. The agreement will be in such form as the Board may from time to time approve or authorize the officers of the Corporation to enter into and may contain such terms as may be considered necessary in order that the Option will comply with any provisions respecting Options in the income tax or other laws in force in any country or jurisdiction of which the person to whom the Option is granted may from time to time be a resident or citizen or the rules of any regulatory body having jurisdiction over the Corporation. Such agreements may also contain such other provisions not inconsistent with the provisions hereof as the Board may determine.

18. Amendment or Discontinuance of the Plan

This Plan and any Options granted pursuant to the Plan may be amended, modified or terminated by the Board without approval of the Shareholders subject to any required approval of the Exchange. Notwithstanding the foregoing, the Plan or any Options may not be amended without shareholder approval to:

- (a) increase the number of Common Shares reserved for issuance under the Plan pursuant to Section 5(a) hereof;
- (b) increase the number of Common Shares reserved for issuance to Insiders or issuable to Insiders in any one year period pursuant to Section 5(b) hereof;
- (c) increase the number or value of Common Shares reserved for issuance or permitted to be issued or granted to Non-Management Directors pursuant to Section 5(c) hereof;
- (d) reduce the Exercise Price of any Option granted pursuant to the Plan;
- (e) extend the expiry date of any outstanding Options other than as permitted pursuant to the Plan;
- (f) permit an Optionee to transfer or assign Options to a new beneficial holder, other than for estate settlement purposes; or
- (g) amend this Section 18.

In addition, no amendment to the Plan or Options granted pursuant to the Plan may be made without the consent of the Optionee, if it adversely alters or impairs the rights of any Optionee in respect of any Option previously granted to such Optionee under the Plan.

19. Tax Withholding

The Corporation shall have the power and the right to deduct or withhold, or require (as a condition of exercise), an Optionee to remit to the Corporation, the required amount to satisfy, in whole or in part, federal, provincial, and local taxes, domestic or foreign, required by law or regulation to be

withheld in respect to any taxable event arising as a result of the Plan, including the grant or exercise of Options granted under the Plan. With respect to required withholding, the Corporation shall have the irrevocable right to (and the Optionee consents to) the Corporation setting off any amounts required to be withheld, in whole or in part, against amounts otherwise owing by the Corporation to such Optionee (whether arising pursuant to the Optionee providing services on an ongoing basis to the Corporation or otherwise), or may make such other arrangements satisfactory to the Optionee and the Corporation. In addition, the Corporation may elect in its sole discretion, to satisfy the withholding requirement, in whole or in part, by withholding such number of Common Shares as it determines are required to be sold by the Corporation, as trustee to satisfy the withholding obligation net of selling costs (which costs shall be the responsibility of the Optionee and which shall be and are authorized to be deducted from the proceeds of the sale). The Optionee consents to such sale and grants to the Corporation an irrevocable power of attorney to effect the sale of such Shares and acknowledges and agrees that the Corporation does not accept responsibility for the price obtained on the sale of Common Shares. Any reference in this Plan to the issuance of Common Shares or a payment of cash is expressly subject to this Section 19.

20. No Guarantee Regarding Tax Treatment

Participants (or their beneficiaries) shall be responsible for all taxes with respect to any Option under the Plan, whether arising as a result of the grant or exercise of Options or otherwise. The Corporation and the Board make no guarantees to any person regarding the tax treatment of an Option or payments made under the Plan and none of the Corporation, its subsidiaries or any of its employees or representatives shall have any liability to a Participant with respect thereto.

21. Independent Advice

Participants are encouraged to seek tax advice in respect of the grant and exercise of Options and the issuance of the resulting Common Shares. Participants who are not employees, officers or directors of the Corporation (i.e. consultants and other Service Providers) should be aware that the tax consequences of being granted and exercising Options and selling Common Shares may be materially less favourable than the consequences to employees, officers and directors of the Corporation who are granted Options as such and receive the benefit of the "stock option rules" under the *Income Tax Act* (Canada).

22. Effective Time

This Plan shall be effective as of April 11, 2016.
